Hereinafter jointly to as "THE TRUSTEE" (which expression shall, unless excluded by or repugnant to the context, be deemed to include the trustee or trustees for the time being of these presents and their successors in office) of the part.

Whereas the settler is a good businessman and a reputed personality of the locality desired to establish a trust for public charitable objects of running educational institutions.

AND whereas the Founder trustees had at the request of the settler on 23rd August 2018 agreed to act as the first trustees of these presents with initial donation of the value of Rs. 1,00,000/- (Rupees: One Lac Only) which was agreed to hand over and set apart by the author with effect from 23rd August, 2018. Besides this trust fund, there is no other property in the name of this trust.

AND whereas it is necessary to get the trust deed registered and declared the objects and terms of the public charitable trust, constituted under these presents.

Now this indenture witness as follows:

CREATION OF TRUST:

1. That, in order to effectuate his aforesaid desire, the settler agreed on 23rd August 2018 to set apart and hand over to the trustees Rs. 1,00,000/- (Rupees: One Lac One Thousand Only) as initial donation (hereinafter called the "TRUST FUND" which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of Law or otherwise howsoever in relation to these presents) are held and stood possessed by the trustees for the trust subject to the powers, provisions, agreements and declarations hereinafter contained hereto in this deed. Besides the above mentioned trust fund, there is no other property in the name of this trust.

"YADUHARIRAM TRUST"

3. PLACE OF OFFICE: The principal place of office of the trust shall be situated at Village- Madhaul, P.O. Susta Madhopur, P.S. Kudhani, District-Muzaffarpur (BIHAR) Pin- 842002. The trust may, however, open its office/ sub-offices/ Branches at places as may be considered necessary by the Board of Trustees from time-to-time.

4. OBJECTS:

- A. That the MAIN OBJECTS for which this trust is established are:
- (a) To establish, run, support, develop and maintain educational Institutes, schools, colleges, Coaching centre for various competitive Examinations, tests and interview, vocational and professional training institute, Management Institute, libraries, reading rooms, universities, laboratories, research and other institutions of the like nature in India, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.
- (b) To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without any distinction as to caste, color, race, creed or sex.
- (c) To promote, establish, support, maintain or grant aid to institutions for the promotion of science. literature, music drama and fine arts and for the research and other Institutions in India having similar objects for the benefit of the public in general.
- (d) To establish, maintain or grant aid for the establishment and for maintenance of hostels, boarding houses, parks, gardens, gymnasiums, sports clubs, solar parks for all round development of students.
- (e) To establish, maintain or grant aid to establishments for the purpose of education and help to the poor, needy and destitute people, orphans, widows and aged persons and to educate them for better life and prosperity.
- (f) To establish and develop educational institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.
- (g) To grant aid or render assistance to other public educational trusts or institutions and to undertake any activity of charitable nature for the sole purpose of education, training and research.
