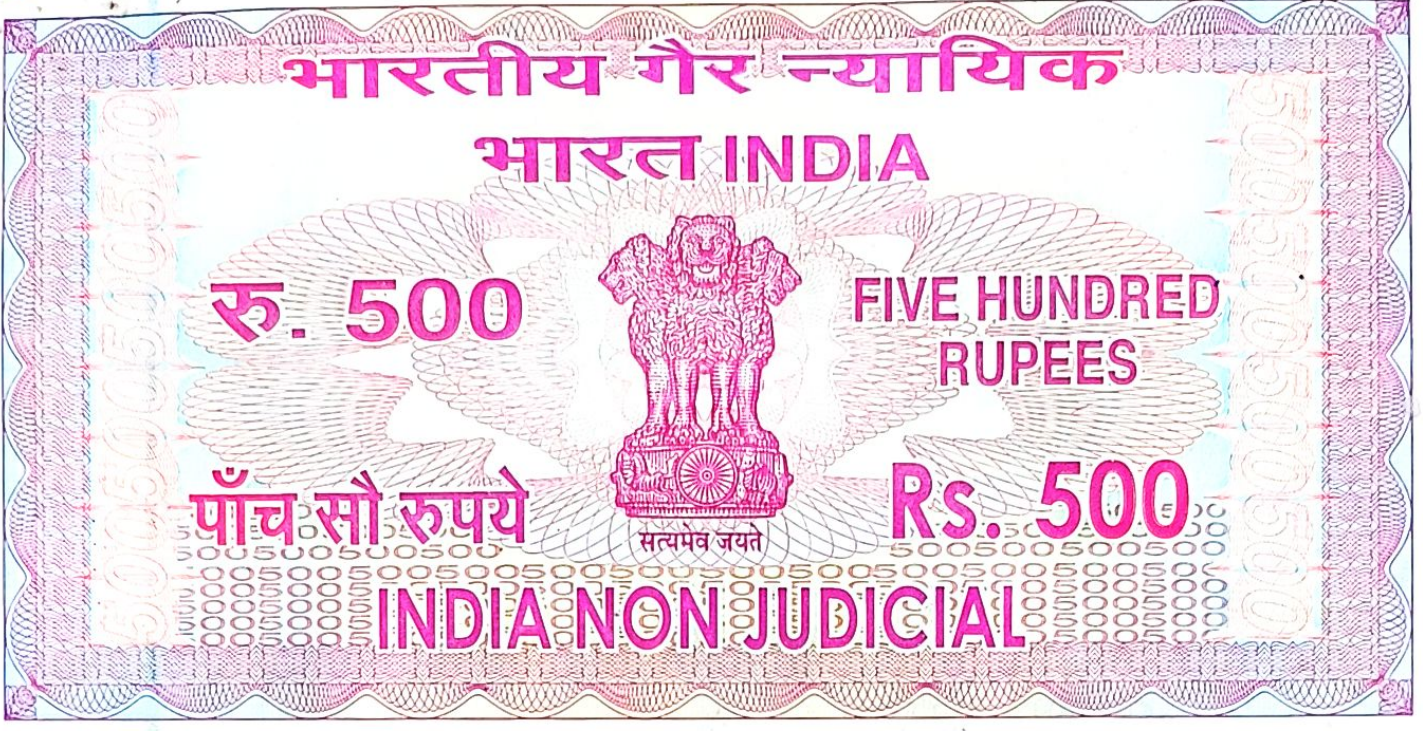

NOW THIS DECLARATION WITNESSTH AND IT IS HEREBY AGREED AND DECLARED AS FOLLOWS :

(i) The Name of the TRUST shall be - **THE LOTUS EDUCATIONAL & WELFARE TRUST.**

(ii) Registered office of the Trust will be located At.-Shivganj, P.O.-Narkataiganj, P.s.-Shikarpur, District-West Champaran, which may be shifted from time to time to such other place or places as the Trustees may deem fit and proper at their diseration.

(iii) AIMS AND OBJECTS :

- a) To establish, promote, set up, run and maintain centres of education, institution of research, child and welfare centres.
- b) To open, found, establish, promote, set, run, maintain and assist schools, colleges and other establishment or institution for advancement of education and of knowledge in Arts, Science, literature and all other userul Subjects.
- c) To promote, advance and encourage primary, secondary and Higher education including technical and medical education also physical training, training of handicraft, fine arts and other

useful arts, crafts among the public including the establishment and maintenance of Shilp-Shikshalaya, kala kendra and other welfare centre for them.

d) To meet travelling, boarding and lodging express for students going abroad for higher commercial and technical education.

e) To grant, pay or give scholarship, stipends, prizes, rewards and other financial assistance or help in cash or king to students with a view to help them prosecuting their studies in schools, colleges, educational institution, technical instutions, art schools, or other educational works in India or abroad.

f) To introduce latest and appropriate techonology which will be suitable for the area of operation and train the people to get the advantage of technology.

g) To start, maintain and assist any relief measures in those parts which are or become subjected to natural clamities such as flood, fire, drought, famine, cyclone, earthquake, epedemic, accident etc.

h) To organise conferences, seminars, training camps and shivirs with a view to provide facilities to common people to give knowledge for understanding the necessity of social, educational, cultural and economical change.

i) Do all such acts and things as may be conducive to the general well being of the society and uplifting the social, educational, economical and cultural condition of the masses.

The management and control of the Trust properties shall vest in the Board of Trustees which shall strive to accomplish the aims and objects of the Trust in accordance with the Rules and regulations enumerated below.

5. RULES AND REGULATIONS :

- i) The Board & Trustees shall consist of a minimum of three and a maximum of nine Trustees.
- ii) The Board & Trustees shall have chairman, vice chairman, secretary cum Treasurer as office bearer whose tenure shall be life long.
- iii) a) The Chairman will preside over all the meetings of the Board.  
b) The Vice Chairman shall execute the function of the Chairman in latters absence.  
c) The Secretary cum Treasurer of the Board of Trustees shall be the Chief Executive to carryout all the executive functions of the Trust in the process of the ccomplicement of its aims and objects, maintainj proper books, records and proceedings of the meeting of the Board and to issue notices in respect of calling meetings of the Board. He shall be responsible for day to day management of the Trust.
- iv) Board of Trustees shall hold its meeting at least once in six months.
- v) Board of Trustees shall be, vested with the exercise of all powers necessary for the Turst's management, administration,

functioning, disbursement of fund, making of donations and investment thereto.

vi) The Trustees may also appoint additional Trustee or Trustees who shall always be an Indian domicilled in India, provided that by appointment of such additional Trustees, the number of Trustees fixed is not exceeded. Upon every such appointment the newly appointed Trustees shall have all powers and authority of a Trustee under there presents.

vii) Without prejudice to aforesaid general powers the Board of Trustees shall have the following rights and powers :

a) To frame, ulter and modify or add or delete from the Rules and Regulations of the Trust.

b) To appoint executives, Assistants and employees for permanent, temporary or special services to fix their remuneration and terms and conditions of service and to dispeuce with their service as and when the Board of Trustees thinks fit.

c) To raise fund and aquire property by donation in cash and kind, grants or loan from public or government and non government agencies, National and international charities, banks and other financiers to achieve the abovesaid objects.

d) To open and maintain account or accounts in the name of Trust in such Bank or Banks as the Trustees may think fit and to operate the same or behalf of the Trust or to delegate one or more persons to do so.

e) To delegate all or any of its powers with authority to sub

ix) All proceedings and questions and matters arising at the meeting of the Board of Trustees shall be decided by a majority of votes and in case of equality of votes the Chairman shall have a second or casting vote.

x) In case of the THE LOTUS EDUCATIONAL AND WELFARE TRUST is wound up or any day, then if there be any asset, then in that case after meeting the liabilities of the Trust, the balance will be handed over to a similar organisation within the District and if there be no such organisation within the District, the same will be handed over to a similar organisation within state.
