AND further whereas a above mentioned Trustees have given their respective consent and have agreed to act as Trustees for the attainments of the Aims and Objectives of this Trust.

AIMS AND OBJECTS

The aims and objectives for which this Trust has been created are as under :-

That in order to effectuate the above said desire, the settler has set apart and handed over a sum of Rs. 5,000/- (Five Thousand) hereinafter called the Trust Fund which expression shall include cash and any other property or instruments of any kind whatsoever into or any part thereof might be converted, invested or varied from time to time or which may be acquired by the Trustees or may come to their hand by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents and the Trustees shall hold and found possessed of the same upon the Trust subject to the power, provisions, agreements and declarations hereinafter contained.

1) To provide value based modern Education from Primary to (10 + 2) level based on C.B.S.E. pattern and also Bihar School Examination Board.

2) To establish, develop, maintain and grant aid in cash or in kind to hospitals, colleges, schools, child welfare, village level services and also to conduct Rural Awareness Programme, Mahila Sakchharta Education, to carry private Employment Schemes, Rehabilitation Programmes and Eye camps.

3) To establish, run, support and grant and on other hand other financial assistance to libraries, reading rooms, meeting halls for the use of students and the staff and for the development and advancement of education amongst the public in general.

4) To establish and maintain Parks, Gardens; Zimnasium, Sports club for the use of students.

5) To offer, take technical knowledge of well known educationist with or without help from external agencies or institutions.

6) To make plan and formulation of development projects independently or in association with other agencies.

7) To make, vary, alter or modify schemes, rules and regulations for carrying of the objects of the Trust.

8) To work for the welfare of economically weak students and their problems relating to their education.

9) To grant, pay or give rewards to students with a view to help them in prosecuting their skill.

10) To publish books, pamphlets, periodicals, magazines and other educational pamphlets for the spread and advancement of education,

11) To give, provide, render help and assistance for the upliftment of the poor boys.

12) To receive and collect any gift, subscriptions and donation either in cash or in kind or acquired by any other lawful ways and means and open the same in fulfilment of all or any of the object of the Trust.

13) To acquire by purchase, take on lease, hire by gift or otherwise hold any movable and immovable property or properties and any right or privilege may be deemed of necessary and useful for the advancement and betterment of the objects of the institutions.

14) To apply the whole or any part of the income of Trust or the Trust Fund or accumulations there to, to any or more of the objects of the trust, as the Trustees may, in their discretion, deem fit from time to time.

POWER AND FUNCTIONS OF THE TRUSTEES

1) To open account in the name of the Trust, Trustees and/or institutions run/conducted by the Trust with a Bank or Banks to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.

2) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding of the Trust Fund.

3) To make, vary, alter or modify schemes, rules

and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution is furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.

4) To set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund or part, thereof, for any of the objects of the Trust.

5) To take over or amalgamate with any other charitable Trust, association or institution with similar objects.

6) Without prejudice to the generally of the above objects and for the effectually carrying out the same, the Trust shall have the power to receive, hold and possess any property including securities of any kind and to contract and maintain any building to manage, transfer or otherwise dispose of or deal in any property of security and to enter into any contract in which the Trust may be interested.

MEMBERSHIP

No person shall be eligible to be a Trustee if he is -

- i) An undischarged insolvent or insane.
- ii) Convicted of any offence involving moral turpitude or
- iii) A minor.

CESSATION OF THE MEMBERSHIP

A person shall cease to be a Trustee in any of the following reasons -

- i) If he/she dies or
- ii) If he/she becomes bankrupt.
- iii) If he/she becomes incapable to act
- iv) If he/she resigns.
- v) If he/she is convicted of any criminal offence.

By an unanimous vote of all the Trustees, any Trustee or office bearer can be removed if it is found to be guilty of serious misconduct.

APPEAL AND READMISSION OF MEMBERS

If any terminated Trustee or office bearer wishing to appeal for readmission, he shall be allowed to make appeal to the Board of the Trustees with full facts and figures justifying validity of his membership. After satisfactory appeal, Board of Trustees may re-admit the Trustee concerned or may turn down the appeal.

GENERAL BODY

The General Body of the Trust shall consist of Trustees, General Member and Institutional Member of the Trust.

The General Body shall normally meet once in a year to discuss and approve the Annual Report and Audit Report of the Trust.

The meeting of the General Body shall be called by the Chairman which shall be presided over by him (The Chairman).

FUNDS AND PROPERTIES OF THE TRUST

The corpus fund of the Trust shall consist of donations of the Trustees and general contributions.

Annual contributions received from affiliated associations and organisations.

Subscription and donations collected from the Public loans from the Banks and Financial Institutions.

Donations and grants collected from the state and Central Government and other social organisations or Corporate Bodies in India and Abroad.

All Funds, Donations, Contributions, Income from the investments, received in any shape or form of to the said Fund, shall be held upon the Trust for the Objects and Aims and Purposes and will be subject to the power and provisions hereinafter mentioned.

No Income of the Trust or benefits from the Trust funds will be distributed or diverted for the benefits of the Trustees or its Members.

AMENDMENTS OF THE DEED FUND OF TRUST

The Board of the Trustees by a resolution attended in person by 2/3 of the total members at a special meeting of the Board of Trustees may change, amend, modify, delete or alter this deed of Trust including aims and objects.

HOWEVER such changes or alterations, amendments, deletion etc should not alter in any way of the nature or character of the Trust and that neither the founder/settler nor the Trustees shall have any power to revoke the objectives and aims of this Trust at any time or at any level.

CHAIRMAN

The settler or and Main Trustee shall be the chairman of the Board of Trustees as well as chairman of the Executive Committee. In the event of vacancy of the chairman caused by the death, resignation or otherwise a person amongst the children of Chairman or previously nominated person shall be the chairman or the remaining Trustees shall elect a chairman from amongst themselves. A candidate who gets the highest number of votes of the present Trustees in a meeting specially called for this purpose. The chairman so elected shall hold office for a period of 5 (Five) years. However the chairman so elected shall be eligible for re-election.

The Present Chairman shall have control over all the affairs of Trust and he will be the chairman of the Trust till his life time.

The Chairman shall be the Head of the Trust and shall be competent to represent the Trust. He shall be the chief custodian and Financial Authority of the Trust and shall exercise overall supervision and control over the Trust. In consultation with other Trustees, the chairman shall be capable to appoint, recruit for different department of the institutions running under the Trust as well as also nominate suitable persons in the Managing Committees.

The Chairman shall ensure that the aims and objectives and rules and regulations of the Trust are duly implemented, he shall have all powers necessary, observance of the staff who violate the aims and objectives and rules and regulations of the Trust.

TREASURER

The Treasurer shall be nominated by the chairman with the consultation and consult of the Trustees for a period of five years from amongst the Trustees.

The Treasurer shall manage the funds of the Trust and ensure that expenditure is incurred for approved purposes and money is granted or sanctioned by the competent authority.

The Treasurer shall ensure that the Account of the Trust is regularly audited and the Annual Audit Report is presented before Board of Trustees.

The Trustees shall have the power to create various posts and appoint the staff of the Trust and decide the conditions; remuneration and mode of recruitment with the consent of Chairman.

The Trustees including the Settler/Author/Chairman shall have the power to approve the Budget Accounts and Audit Report of the Trust.
