

And whereas the founder trustees had at the request of the settlor, agreed to act as the first trustees with initial donation of Rs-100000 (One lac only) set a part by the author on 05th day of October 2017.

AND whereas it is necessary to get the Trust deed registered and declared the objects and terms of the public charitable Trust, constituted under these presents.

Now this indenture witness as follows:

CREATION OF TRUST:

01. That, in order to effectuate his aforesaid desire, the settlor set apart and handed over to the trustees a sum of Rs 100000/- (One lac only.) (here in after called the "Trust Fund" on 5th day of June 2016 which expression shall include cash and any other assets or investments of any kind whatsoever into which the same or any part thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the Trust subject to the powers, provisions, agreements and declarations herein after contained in this deed.

02. The name of trust shall be:

"ROSHANI EDUCATIONAL AND WELFARE TRUST (R.E.W.T.)"

03. **PLACE OF OFFICE :**

The principal place of office of the Trust is presently situated in At + P.O. + P.S.- Turkaulia, Distt.- East Champaran (Bihar). The trust may however open its office/sub-offices/branches at places as may be considered necessary by the board of trustees from time-to-time.

04. **OBJECTS:**

A. That the MAIN OBJECTS for which this trust is established are:

- (i) To establish manage and run **"ROSHANI EDUCATIONAL AND WELFARE TRUST (R.E.W.T.)"** At + P.O. + P.S.- Turkaulia, Distt.- East Champaran.
- (ii) To establish, run, support, develop, and maintain schools, colleges, libraries, reading rooms, universities, laboratories, research and other

In furtherance of the above objects and other objects hereinafter contained in this deed the role & responsibilities of the Trustees shall be as under:

- (i) To ensure that the College/School gets proper land, building, equipments, furniture and qualified staff at least as per the norms of the apex conferencing body .
- (ii) To ensure that the College/School is run as a community service and not as a business and that commercialization does not take place in the institution in any shape whatsoever.
- (iii) To safeguard the autonomy of the principal and provide him total support except when the Principal goes against the established and clear directives laid down by the management.
- (iv) To have control over the College/School Management Committee and shall approve the budget/tuition fees and annual charges etc. for the college/ school.
- (v) To have control over any capital expenditure.
- (vi) To generate funds for the needs of the college/school whether it is recurring or non- recurring.
- (vii) To generate funds for the needs of the college/school has the basic essential facilities such as laboratory Equipments, games and sports articles and other co-curricular activities, Library Books etc.
- (viii) To ensure that the college/school is running as per the provisions of the education act/affiliation norms and is providing quality education to the children and for this to take necessary steps as per its need.

05. **DONATIONS & CONTRIBUTIONS:**

That the trust Fund may be augmented by the income from the initial fund and also by donations and other contributions.

06. **APPLICATION OF TRUST FUND:**

That the Trust Fund shall not be applied for any purpose other than those specified in para 4 hereinafter.

07. **ACCOUNTS AND AUDIT:**

That the Trustees shall always maintain proper accounts of the Trust which shall be kept at the office of the Trust. Annual accounts of the Trust shall be audited by a Chartered Accountant.

08. **POWERS OF TRUSTEES:**

That for the furtherance of the objects of the trust, the trustees shall have the following powers:

- (a) The Trustees will advise and support the office bearers to carry on day to day affairs of the trust.
- (b) To constitute different committees like selection committee, departmental promotion committees for various categories of staff.
- (c) To lay down conditions of service as per norms of NCTE/CBSE/Govt. and to approve promotion /appointment/ termination of the employees as well as to grant special increments or rewards to the staffs.
- (d) To accept any donation, contribution, grant or subscription in cash or in kind, from any person (s), body of persons or trust, with or without conditions.
- (e) To apply the whole or any part of the income of the trust, or the trust fund or accumulations there to any one or more of the objects of the trust as the trustees may in their discretion, deem fit from time to time.
- (f) To convert and deal with the trust property and/or any investments for the time being.
- (g) To invest the Trust Fund in shares, stock or debentures or other securities and investments in deposits with or loans to any company, bank, firm or any other person and to alter, vary or transpose such investments, from time to time at the discretion of the trustees.
- (h) To borrow or raise or secure payments of moneys and also to lend money either with or without security.
- (i) To let out, demise any property comprising in the Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.
- (j) To open account in the name of the trust/Trustees and/or institution run/conducted by the Trust with a bank, to operate such account

and to give instructions to the bank and to provide for opening and operation of such account by the trustees or by a representative appointed by the Trustees.

- (k) To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceeding regarding the Trust fund.
- (l) To appoint or make provision for the appointment of any person for the purpose of the administration of the trust in such manner and subjects to such rules and regulations as the Trustees to hold any fund or investment subjects to the provisions of this deed in such manner and subjects to such rules and regulations as the trustees may from time to time think fit.
- (m) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the managements of the affairs thereof and/or running any institution in furtherance of the trust and otherwise for giving effect to the objects of the trust.
- (n) To start, discontinue and restart any charity or charitable institutions for the benefit of general public and to impose any conditions to any subscriptions or donations made by them.
- (o) To set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund or part thereof for any of the objects of the trust.
- (p) To join, co-operate or amalgamate this trust with other or others having similar or allied objects, upon such terms and conditions as the trustees may in their discretion think fit, particular having regard to and in conformity with the objects and nature of this trust.
- (q) To settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings or disputes, claim demand or things as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- (r) To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or trust in India which may have been established for the like charitable purposes mentioned in these presents or any of them to enable such institution, societies, organization or Trustees to start maintain, or carryout such charitable objects.

- (s) To borrow moneys either on the security of any property comprised in the trust Fund or otherwise for all or any of the purposes of these presents and it shall be lawful for the trustees to make such borrowings or payments of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit. To apply to the Govt., public bodies, any bank, urban, local, municipal, district, and other bodies, corporation, companies, or presents for and to accept grant of money and of aid, donations gifts, subscriptions and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the Govt., public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to confirm to any proper condition upon which such grants and other payments may be made.
- (t) To take over or amalgamate with any other charitable Trust, society, association or institution with similar objects.
- (u) To establish, manage organize or maintain or to maintaining any branch of the Trust or its branch with objects similar to those of this trust and to promote or carry on the affiliation or amalgamation of such other Trust with this Trust.
- (v) To take over, acquire, manage, control, or aid any existing institutions having objects either wholly or in part similar to the objects of this trust and on such terms and conditions as may be thought expedient.
- (w) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institution or associations with which this trust is authorized to amalgamate.
- (x) To transfer and hand over the trust to any other society, corporation, institution, trust or organization on such terms and conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the society, corporation, institution, Trust or organization with the power, provision, agreements and declarations, appearing and contained in these present subjects to such modifications as may be necessary and consequent to such transfer of the trust fund. The Trustees for the time being of these presents shall become discharged from the trust hereof relating to trust funds so transferred.

09. POWERS AND FUNCTIONS OF OFFICE BEARERS.



THE CHAIRMAN shall be the chief functionary of the trust and shall be responsible for the following functions:-

- (i) He shall be head of the Board of Trustees or The Trust;
- (ii) To look after the day to day functioning of the trust and will exercise powers under the direction and guidance of the founder trustees;
- (iii) To establish contract, negotiate and conclude contract, arrangements etc. With outside agencies taking assignments, projects and other works for and on behalf of the trust;
- (iv) To do all other functions related to and incidentally thereof on behalf of the Trust.
- (v) He may advise the secretary to call a meeting of the Board of Trustees;
- (vi) To preside over all the meetings of Board of trustees, Founder Trustees and Annual General Meeting as ex-officio Chairman;

POWER OF THE VICE- CHAIRMAN

- (i) In absence of The Chairman the Vice-Chairman shall preside all the meetings of the Trust ;
- (ii) And he/she will exercise all the powers of Chairman in his absence;
- (iii) He / She will act and perform the specific works with the suggestion and guidance of the Chairman;
- (iv) In case of vacancy he/she will act as the Chairman till the further appointment.

POWERS OF THE SECRETARY

- (i) He / She shall be act as the Secretary of the Trust;
- (ii) He /She shall call and attend the meetings of the Board of Trustees and The General Body and shall be responsible for recording the proceedings thereof in the minutes book according to the advise of Chairman.
- (iii) To keep a record of the proceeding of the founder trustees, Board of trustees, general Meeting;

- (iv) To maintain a register of trustees/members with such particulars as may be determined by the board of trustees;
- (v) To carry on correspondence on behalf of the trust and to have in custody the records and files of the trust;
- (vi) To execute the policy decisions of the Board of Trustees and founder trustees on behalf of the Trust.

POWER OF THE JOINT SECRETARY

- (i) In absence of The Secretary the Joint Secretary shall call and attend all the meetings of the trust;
- (ii) And he/she will exercise all the powers of The Secretary in his absence;
- (iii) He / She will act and perform the specific works with the suggestion of the Secretary;
- (iv) In case of vacancy he/she will act as the Secretary till the further appointment.

POWER OF THE TREASURER

- (i) He /She will be responsible for all the accounts related works of The Trust;
- (ii) To prepare and present annual accounts of the Trust and to ensure annual audit of the accounts of the trust;
- (iii) To prepare and present periodically to the Board of trustees a true and correct picture of the expenditure of the trust;
- (iv) All dues and Donations shall be deposited with the treasurer who will deposited the same with the bankers of the Trust, if found surplus keeping in view monthly expenditures;
- (v) He shall maintain proper books of accounts, get the accounts audited and shall furnish statement of accounts as and when demanded by The President or Board of Trustees.

13. The Board of Trustees for the time being will be at liberty to appoint additional Trustees for such period on such terms as to retirement and re-appointment as the trustees for the time being considered proper. Any founder trustee if he/she incapable of discharge in his duties, may at his own discretion nominate his/her legal heir, for the purpose to carry forward the responsibilities assigned to him by the Trust and the person nominated shall become the founder Trustee.

Any casual vacancy in the founder trustees shall be filled up by the legal heir of the founder trustee by whom the seat is vacated. If any of the founder trustees resign & refuse to remain associated with the trust and in this case doesn't nominate any of his legal heirs the casual vacancy created in this manner shall be filled up by co-option by the remaining founder trustees and this co-option shall be unanimous or with the written consent of all the remaining founder trustees.

14. **RULES AND REGULATIONS:**

- (a) The founder trustees may from time to time frame rules and regulations for the trust, educational institutions nursing and maternity homes or other establishments, branches and/or divisions or otherwise. In framing the rules and regulations by the founder trustees advice/recommendations of the trustees other than founder trustees shall be recorded and discussed by the founder trustees in its meeting. The founder trustees can never be removed from the trust.
- (b) The founder trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations:-
- (i) Two- Third number of trustees rounded to higher number subject to minimum three shall form a quorum for a meeting of the trustees.
- (ii) Resolution passed without any meeting of the trustees but by circulation thereof and evidenced in writing under the hands of four-fifth trustees shall be as valid and effectual as a resolution duly passed at a meeting of trustees.
