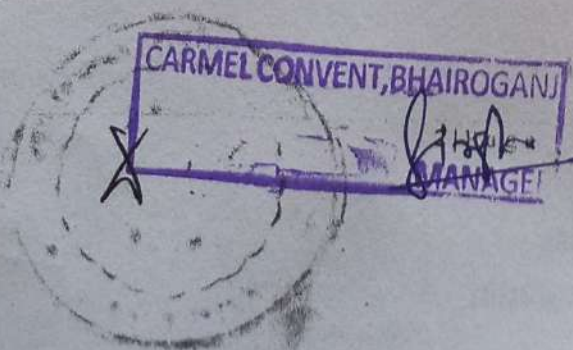

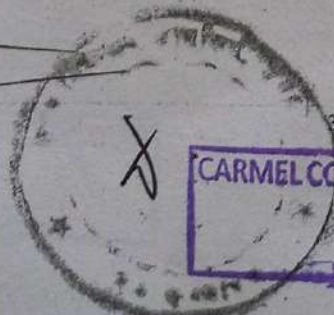

- c. To propagate, popularize, prepare, disseminate, advertise and communicate courses, articles, features, documentaries, articles, matters by means of video cassettes, C.D, DVD, video and cinematograph film, pre-recorded audio tapes and other medium for the promotions of the objects of the trust.
- d. To initiate, sponsor, provide, and contribute for scholarships prizes, grants, Aids, Awards, Trophies and allied assistances for the promotions of the object of the trust.
- e. To seek, solicit, qualify for and obtain approval, recognition and affiliation from central govt., state govt, CBSE, ICSE, UGC, AICTE, MCI, DCI, Universities, Board and other competent authorities.

- f. To enter into the arrangements with central, state, municipal, local or other Govt., or authorities, that they may be seen conducive to the trust's objects or any of them and to obtain from any such govt. or authorities, any franchise, rights, privilege and concessions with the trust may think desirable to obtain any connection with its activities and to carry out and comply with any such arrangement and to exercise to dispose of otherwise term to account any such right privilege and concessions.

To grant remuneration, salary, fees, allowance, perquisites, pension, gratitude, emoluments and bonuses and provident fund and other admissible benefits to its employees, former employees, authorities and office bearer of the trust and their windows and children of such persons and such dependents upon them and construct or contribute to the construction of houses, dwelling houses and quarters for the employees of the trust and of other person which are or may be in contractual or professional relationship with or rendering any services to the trust
- j. To earn incomes from the activities of the trust and to pay for all expenses for the objects of the trust.

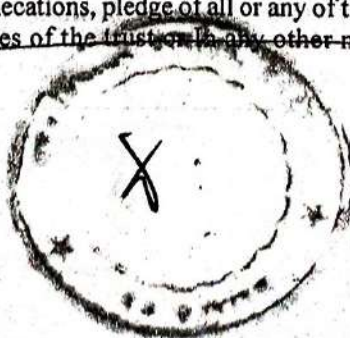

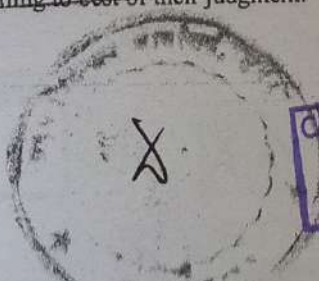
5. SOURCES OF INCOME OF THE TRUST

To invest the trust fund either in the purpose of mortgage of ~~immovable property or in shares stocks or deventures~~ or other securities and investment or in deposit with or loan to any company bank firm or and other persons and or alter vary or transpose such investment from time to time at descretion of the trustees.
- e. To borrow or raise or secure payment of money and also to lend money either with our without security.
- f. To let out, demise any immovable property comprised in the Trust fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.
- g. To open account in the name of the trust in accordance with the objects led down and above.
- h. To appointed attorney, delegates, agents, representatives and other professionals for the furtherance of the object of the Trust as the Trustees may deem fit and proper.
- i. To frame rule and regulations for the administration of the trust and for carrying out the purposes and objects there of and the same may be varied alter substituted or added from time to time by unanimous decision of the board of Trustees with a view to introduce more effective administration and carrying out of the purposes and the objects of the trust.
- j. To constitute the turn of the office bearer of governing body among the trustees otherwise or may appointed authority employees as they think fit and proper for the sake of administration and implementation of its decision in furtherance of the aims and object of the trust the board shall also decide from time to time the amount of remuneration/fees/honorarium of the office bearer to be paid of them.
- k. To do all other necessary or lawful things which may be necessary for the furtherance of the objects of the Trust. Now ever it the Board of Trustees think to do other thing beyond the power conferred bit the Author as mentioned aforesaid the same may be done after obtaining written constant of the Author of this Trust within the limitation laid down its objects.

7. BOARD OF TRUSTEES MEETING & ITS LIMITATIONS

The number of the trustees at any time shall not be less than three and more than seven in the event of death, incapacity, Insolvency, resignation, remaining trustees shall be entitled to nominate any other person as that' may think fit and proper to act as trustee in place of the trustee so dying, incapacitated, declared, insolvent,

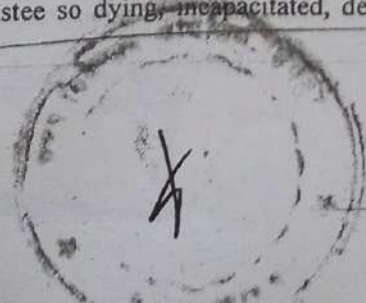

resigning or refusing to act as such Nomination of any person as a trustee shall be by =

- a. Majority decision of that existed trustee and in event of the trustees being equally divided on the nomination of any person the decision in the matter of Managing Trustees shall be final and conclusive.
- b. The Board of trustees may elect or nominate any one of them as Managing Trustee for any period of time but the first Trustee shall be KRISHNA SINGH and he shall hold that office and position for any period of time of the Board of trustee decide from time to time.
- c. The first meeting of the Board trustee shall be held within three months of the date of execution of this Deed and shall be summoned by the Author of the Trust by giving at seven days notice in writing to all the trustees held at such place and time as may be specified in the notice and in that meeting all relevant matters relating to the trust shall be considered in all possible details and particularly the way and the manner to give to the provisions of the Deed of the Trust and to attain the objects and purposes of this Trust.
- d. The Trustees shall not involve in any actor do anything in their official capacity which would be contrary of the provision of this Deed and decision of the Board of Trustees to be taken time to time.
- e. The trustees may in their own controlled discretion to keep any documents or securities in safe custody which is relating to or forming the trust property with the Banks or trustees may think fit for time being
- f. Meeting of the Board of Trustees may be held at such time at such place and at such date as may agreed upon by the Trustees. Such meeting may be summoned by the Managing Trustee by giving at least seven days notice in writing to all the trustees.

8. ROLES AND RESPONSIBILITIES: -

- a. To implement the policy decision taken by the Board of Trustee of the trust from time to time in view of the aforesaid aims and object.
- b. To do day to day affairs of the trust particularly in routine nature.
- c. To exercise all kind of power and responsibilities delegated by the Board of Trustees from time to time.
- d. To manage, maintain, plan and control the affairs relating to human resources including the appointment, transfer, posting, dismissal, assigning duties and determining remuneration of the employees.
- e. To authorize and appoint bank signatory and to manage control and ensure smooth operation of all kind of bank accounts of the trust to the extent of powers delegated to the Trustees by these presents.

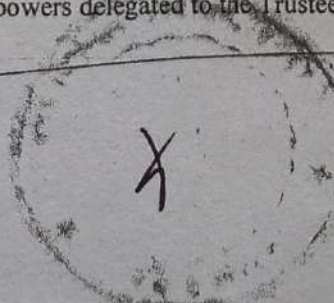

- f. To raise debt, grant and other types of funds from any type of financial institutions individual or any other organisation of the objectives of the Trust these funds are required to meet the administrative expenses and programme expenses of the Trust as well as increasing the corpus of the Trust.
- g. To raise borrowing from various organizations like nationalized Banks, International Banks, External Commercial borrowing, Schedules Commercial banks, Co-operative banks, Private Banks, Financial Institutions and or other similar organizations for further on landing to poor and needy people and our beneficence so as to enable them to develop their sustainable livelihood.
- h. To take necessary instructions and / or advice from the Board of Trustees as and when they need to do so.
- i. It should ensure that the school gets proper land, building equipments, furniture and qualified staff at least as per norms of the Board.
- j. It shall ensure that the school is run as a community service and not as a business and that commercialization does not take place in the school in any shape whatsoever.
- k. It shall ensure that the fund raising from the school are spent for the benefit of the school and for its expansion.
- l. It shall safeguard the autonomy the principal and provide him total support except when the principal goes against the established and clear directive laid down by the arrangement.
- m. It shall have control over the school management committee and shall approve the budget/by tuition fees and annual charges etc. for the school.
- n. It shall have control over any capital expenditure i.e.. on land and the construction of the building, its expansion and procurement of major equipment for the school,
- o. It shall generate funds for the needs of the school weather it is recurring or non-recurring.

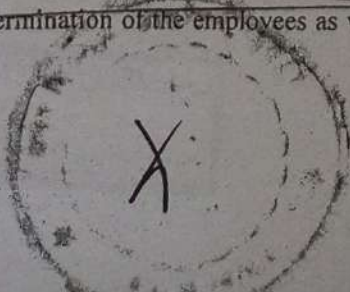

special increments or rewards to the staffs. The Trust will ensure that the school is running as per the education act/affiliation norms and shall be committed to provide quality education to the children and for this shall take necessary steps as per its needs.

9. BOOKS OF ACCOUNTS AND AUDIT:-

- a. The Trust shall keep true and fair accounts of the receipt and payments (Disbursement) in proper manner, maintaining the norms set/laid down by the competent govt. agencies/authorities. The person assigned by the Board of Trustees for the time being shall be responsible to do so the Managing Trustees shall get the accounts, accounts audited 31 March every financial year by chartered accountant and put up the same in the meeting of the Board of Trustees for their duly approval.
- b.
